#### AGRICULTURE EXTENSION EDUCATOR – KEN SCHROEDER

- Organized and hosted the annual Central Wisconsin Processing Crops Meeting at Hancock reaching 30 vegetable growers, crop consultants, and processors.
- Followed up with an afternoon discussion and input gathering session on the drought and climate information needs of specialty crop growers for the National Drought Mitigation Center research project.
- Investigated and co-authored an article addressing the issue of potatoes left in the field from 2018 for the first issue of the Division of Extension Vegetable Crop Update newsletter. #### FOODWISE (KELLY HAMMOND - COORDINATOR; PENNY SCHMITT - EDUCATOR)

- FoodWIse representation at Hunger and Poverty Prevention Partnership, Portage County CAN and Portage County Breastfeeding Coalition.
- Teaching events include: new StrongBodies class at the YMCA with 12 participants, new StongBodies class in Amherst at the Senior Meal site with 25 participants (current waiting list of 9 people). Youth lessons include three 1st grade classes at Mckinley school and 2 Head start classes. (25 total lessons). Team presented SPASH/MATC course on eating on a budget/food security in Portage County for community health course.
- Policy, Systems and Environmental work: co-facilitating poverty workgroup for HPPP, working with Farmshed/PCCAN/Farmers Market Manager to bring EBT back to the Market for summer 2019. (Hammond)

- Resumed discussion about a community revitalization initiative in Junction City through a joint meeting along with CREATE where we did an initial scoping of potential community placemaking efforts and began next steps toward involving more community members.
- Facilitated discussion to assist a county committee in identifying purposeful activities and developing a work plan that may help to coordinate efforts of supervisors and staff involved.
- Continued support Portage County's current SolSmart certification effort by engaging appropriate county colleagues in a series of study presentations, and two webinars examining local plans, ordinances, and permitting provisions related to solar development in Wisconsin.

- Facilitating the Raising a Thinking Child 7-week training, done all online, began on March 26. It is every Tuesday night from 8-9:15pm. We have 12 families with 25 children involved.

Twice a year the Portage County Coalition for AODA Prevention sponsors prescription drug take-back events. The overall goal of the program is to reduce access to potentially dangerous, unused, or expired medications.

#### **Binge Drinking Dangers:**

Binge drinking for women is defined as four (4) or more standard-size drinks in a two hour period and five (5) or more standard-size drinks in that same time-frame for men. A standard drink would be 12 ounces of beer, 5 ounces of wine, or 1.5 ounces of distilled spirits/liquor.

As a concern most often associated with college students, it is important to note that drinking does not have to be part of a student's experience. In fact, 30% of UW-Stevens Point students reported not using alcohol and almost 70% reported drinking 5 or fewer drinks when they party (2017 Center for Prevention Alcohol and Other Drugs Use <a href="https://www.uwsp.edu/dos/aoda-ipy/Documents/AODA%20report.pdf">https://www.uwsp.edu/dos/aoda-ipy/Documents/AODA%20report.pdf</a> ).

This is a concern however for other college students and our communities. The University of Wisconsin System continues to research and work to prevent dangerous alcohol consumption like binge drinking. For their latest information, check out their data sheet on binge drink.
