AWARDS

In addition to the ribbons and premiums awarded at the Rosholt Fair, plaques are awarded to the champions, reserve champions, rate-of-gain champions, showmanship champions and the outstanding exhibitor award recipients in each species. Belt buckles will be awarded to the showmanship winners and director's chairs will be awarded to the champion and reserve champion market animal exhibitors. All animals weighed on and off (which meet the requirements to qualify for the sale) are eligible for the rate-of-gain championships. At the end of the carcass contest, plaques are given to the Grand and Reserve Champion carcass in each species.

Three Clean Barn Award winners (one per species) will be selected at the Rosholt Fair. Criteria are listed in the fair book on page 8. Each youth organization selected for the Clean Barn Award will receive a \$50.00 cash prize from the Market Animal Committee. The winners will be announced at the Carcass Contest.

2024 MARKET ANIMAL PROJECT RULES:

A. PARTICIPANT ELIGIBILITY REQUIREMENTS

1. Only current, active members of Portage County 4-H, FFA or any other recognized Portage County youth organization under adult leadership with a market animal education program that has been approved by the Rosholt Fair Board, are eligible to participate in the Portage County Market Animal Project. **Participants must be in grades 3 through one year beyond high school graduation and not to extend beyond the age of 19 as of December 31, 2023.**
2. All animal exhibitors in the project must have or obtain a premises ID to be in the program. Premises IDs can be obtained by visiting <http://www.wiid.org/> or calling toll-free (888)808-1910.
3. **Each exhibitor who sold an animal in the previous Market Animal Sale MUST have submitted a copy of the thank-you letter that was sent to his/her buyer no later than October 15th of the sale year in order to be eligible to participate in the Market Animal Project the following year. (New project members should refer to the details about thank-you letters on page 8, G11)**
4. The registration deadline for the 2024 Market Animal Project was December 15, 2023.

B. WEIGH-ON

1. **Age of project animals.** Market beef must be born on or after January 1 of the previous year. Market swine and lambs must be born on or after January 1 of the current year.
2. Project animals may be market beef steers or heifers, swine barrows or gilts, sheep wethers or ewe lambs. Males must be castrated (testicles physically removed) prior to weigh-on. Any banded scrotum must be healed and devoid of testicular tissue as determined by the veterinarian or committee. No emasculating (crushing).
3. **Limit of two head per species**, per exhibitor, to be weighed on for the Market Animal Project. Families with two or more project members who only weigh on one animal per species each, may weigh on up to two additional joint project animals per family. These “floater” animals may be shown and sold by any of the market animal project members in that family. At the time of weigh-off, each “floater” animal must be assigned to a specific project member. **Market animals may not be a managerial project.**
4. Ear tag(s) will be placed in ear(s) of all beef and sheep project animals at the time of weigh-on.
5. Beef cannot weigh more than 1,100 pounds at weigh-on. They must be dehorned prior to weigh-on. **Scurs are not attached to the skull with bone and do not pose a safety hazard.** Beef must be haltered during the weigh-on process.
6. It is recommended that lambs do not weigh more than **90** pounds at weigh-on. All lambs’ tails must be docked prior to weigh-on.
7. All animals will be weighed on only once. Handling of animals is the responsibility of the exhibitor or exhibitor’s family.
8. “Good faith clause” — **Participants have the right to accept or reject the scale weight. If the weight is rejected, the animals will not be allowed in the sale.**
9. The swine show is a terminal show. All animals must be sent to a facility inspected by the USDA or inspected by the state, for processing.

10. Swine must be identified by May 6th. Members must tag, photograph, and electronically submit two photos for each tagged hog — one photo of the entire animal and another photo of the animal showing its tag number. Include project member name with correlating ear tag. Ear tags and ear taggers (if needed) will be distributed at the April 15th YQCA training, between 6:00 and 7:30 pm. Photos must be submitted no later than May 6th to: portageco.map@gmail.com. **YOU WILL RECEIVE A CONFIRMATION E-MAIL AFTER PHOTOS ARE SUBMITTED.** If you do not receive a confirmation e-mail shortly after submission, your photos were not received and you should submit them again.

11. Original ear tag(s) must remain in the animals' ears. If a tag is displaced (i.e., Tag is lost or removed for health reasons), the project member must contact Dr. Barb Kasproicz or Matt Mlodik immediately, or the animal could be disqualified from the Market Animal Project.

12. YQCA is mandatory for all market species (beef, sheep & swine). **YQCA training must be completed no later than July 1st to be eligible for the Market Animal Sale.**

C. EDUCATIONAL REQUIREMENTS

All participants **MUST** attend **THREE** educational meetings to be eligible to participate in the Market Animal Sale. Each event in the table below qualifies as an educational meeting.

Note: To receive credit for an event **not** listed on Pages 3 and 4, you must receive **PRIOR APPROVAL** from Dr. Barb Kasproicz. After attending the event, you must provide proof of attendance by completing a Portage County Youth Livestock Educational Event Verification Form which can be found on the Portage County 4-H website https://portage.extension.wisc.edu/files2021/02/Educational_Verification_Form-fillable2-1.pdf (wisc.edu). Completed form must be submitted to the committee **within 7 days** after attending event. Additional educational events that are posted on the Market Animal Committee's Facebook page (<https://bit.ly/PortageMAP>) do not require prior approval, but they do require a verification form. Only one unlisted event per member per year is allowed. Participation in one FFA career development event in either Livestock Evaluation or Meat Evaluation and Technology at a regional or state location will count for an educational meeting with proof of attendance from your FFA advisor. Youth grade 7 or older may satisfy one educational meeting requirement by attending at least four Market Animal Committee meetings. **The only livestock shows that count for an educational meeting are the Amherst Fair and the State Fair.** With the exception of the State Fair, all educational meeting requirements must be completed by August 1st.

D. PRIOR TO WEIGH-OFF

1. Market Animal Project records must be personally maintained by project members and kept up to date. All forms included in the Market Animal Project binder (Market Animal Project Record, Market Animal

Project Drug History Form, Animal Care Agreement, Species Identification Form, Extra Animal Destination Form, Market Animal Project Member Data Sheet, Wisconsin Owner/Hauler Statement for Sheep) must be completed, signed by your parents and the adult leader of your approved youth organization, and turned in to a committee member **no later than 3 pm on Sunday, August 25th, 2024** (Rosholt Fair Clean-Up Day) in order to be eligible for the Market Animal Sale. If you cannot attend the Clean-Up Day, please send your Market Animal Project binder with another family or leader. After weigh-off, any changes to the Extra Animal Destination form must be discussed with Matt Mlodik.

E. WEIGH-OFF

1. **Project members are responsible for the humane care of their animals from the time the animals arrive at the fairgrounds until the animals leave the fairgrounds. All animals must be given FRESH water and food at least 2 times a day. In addition, the animal pens need to be checked throughout the day for feed, water, and overall cleanliness.**
2. Weigh-off will be held at the Rosholt Fairgrounds: **Friday, August 30, 2024**. You **MAY NOT** unload your animal(s) until they have been inspected by the veterinarian. All animals will be weighed off the trailer from 2 pm to 7 pm.
3. For Swine only, CVI/health certificate **that was obtained during an on-farm visit within 30 days of the fair**, must accompany hogs at unloading.
4. Each exhibitor or family member may weigh off all animals previously weighed on.
5. **If cable halters are used while on the fairgrounds, the cable must be coated.**
6. Joint project animals (floaters) need to be assigned/designated to one exhibitor at time of weigh-off. **The floater needs to be randomly included on one family member's fair entry form** so that the barn supervisor knows how many animals you are bringing.
7. **No attached horns are allowed. Scurs, or horn caps less than 1.5", are permitted.**
8. **Exhibitors MUST select their sale animal no later than time of weigh-off.**
9. All animals will be weighed off only once. Handling of animals is the responsibility of the exhibitor or exhibitor's family.
10. "Good faith clause" — **Participants have the right to accept or reject the scale weight. If the weight is rejected, the animal will not be allowed in the sale.**
11. **Any unmanageable animal that poses a threat to the safety of exhibitors, fairgoers or other animals will be sent home. The decision to send home an animal deemed unmanageable will be made by three members of the Youth Exhibit Committee.**
12. Exhibitors or designee **MUST** attend the weigh-off meeting held at 8:00 pm in the Pinkerton Building.

F. MARKET ANIMAL SHOW

1. All project animals weighed off that meet sale requirements are allowed to show in the Market Animal Project Class (Class B). **When signing up for fair exhibits, enter ALL project animals under Class B. Class C should only be used for non-project animals.**
2. After the final weigh-off, all project animals will be divided into classes based on their weights. Weight classes will be determined by members of the Records Committee. Class divisions will be based on the similarity of weights within a class and the difference in weight between the heaviest animal in the previous class and the lightest animal in the next class.
3. Animal health requirements for County Fairs will apply to the project animals in the Market Show and Sale. Requirements can be found in the fair book, and can change from year to year.
4. Only exhibitors are allowed in the Show and Sale Ring.
5. If the exhibitor has two animals in the same class, they must ask another Rosholt Fair animal exhibitor to show one of the animals for them.
6. If the exhibitor has two animals in the championship drive, the exhibitor cannot win both Grand and Reserve Champion in the same species.
7. **If an exhibitor is not able to control their project animal in the show ring (animal cannot be led around ring or lined up) and three members of the Youth Exhibit Committee determine that the animal poses a threat to the safety of other exhibitors, animals or the judge, the unmanageable animal will be removed from the show ring and WILL NOT be eligible to participate in the Market Animal Sale.**

G. MARKET ANIMAL SALE

1. In order to qualify for the sale, two signed bidder slips must be turned in to the committee by each exhibitor and postmarked by August 1st. **This rule will be strictly enforced.**
2. Grand and Reserve Champion show animals must be sold in the Market Animal Sale. **If the alternate project animal that was not chosen to be in the sale is selected as the Grand or Reserve Champion, that animal will be the sale animal.**
3. Each exhibitor will be allowed to sell one animal in the sale. If exhibitors show more than one species, they must assume the responsibility of selection of the one species that will go into the sale immediately after the market judging is completed. Selection will be determined by the Market Animal Committee only if the exhibitor does not make a selection. In the event that a member should be the exhibitor of more than one species Grand or Reserve Champion, this member is required to sell all Grand or Reserve Champion animals.
4. The physical appearance of market animals, while being displayed in the sale ring, must be in compliance with the same rules that govern the physical appearance of market animals while being judged in the show ring. Refer to the Portage County Fair Animal Exhibitor's Code of Ethics on pages 5-6 of the Portage County Fair Book. Any market animal whose physical appearance deviates from these rules **WILL NOT** be allowed to enter the sale ring until the deviation has been corrected.

5. Market animals must meet all of the following requirements for each species in order to qualify for the Market Animal Project Show and Sale:

- a. Judges will have the discretion to disqualify any animal and remove it from the sale if they deem that it does not meet quality market standards.
- b. Weights will be determined at weigh-off.
- c. Rate of Gain for beef and sheep will be computed at weigh-off.
- d. Quality and yield grade will be determined by the judge.
- e. Although there is not a maximum weight in place for swine, there is a maximum pay-out weight of 300 lbs. In order to align with industry standards, any swine weighing over 300 lbs. will still qualify for the sale if they have met all other requirements, but the maximum pay-out will only be up to 300 lbs.
- f. *There is a maximum pay-out weight of 160 pounds for lambs. Any lamb weighing between 161 and 165 pounds will still qualify for the sale if they have met all other requirements, but the maximum pay-out will only be up to 160 pounds.

6. **Market animals exhibited by youth who did not meet all the required market animal project timelines and market animals that did not meet the requirements listed under G5 may be exhibited under Class C. Please note that Class C only allows for one animal per species to be exhibited. Refer to page 2, item 4, Fair Entries in the Portage County Fair Book.**

7. All livestock to be sold must be identified by a Market Animal information card provided by the committee. It shall be the exhibitor's responsibility to have this card properly completed and displayed over the animal's pen or stall.

8. Sale Order:

- a. **Grand champions will be the first 3 animals sold in the sale according to the following rotation:**

GRAND CHAMPION ROTATION	BEEF	SHEEP	SWINE

- b. Remaining Reserve Champions will be equally distributed in the top half of the sale order. Distribution will be determined by computer randomization.
 - c. Sale order of the remaining market animals will be determined by computer randomization.
9. Neither the Rosholt Fair nor the Sale Committee will make a guarantee as to the selling price.
10. There will be a sales commission of \$35.00 or 4.5%, whichever is greater, deducted from the selling price of each animal to cover expenses and promote the Market Animal Sale.
11. **Each exhibitor who sells an animal in the Market Animal Sale MUST submit a copy of the thank-you letter that was sent to his/her buyer no later than October 15th of the current year in order to be eligible to participate in next year's Market Animal Project.** Copies of letters may be submitted electronically to portageco.map@gmail.com or personally delivered to the UW-Extension office. The electronic submission may be a photo or scanned document. Letters must be legible. You will receive a confirmation e-mail shortly after a copy of your letter was submitted. If you do not receive a confirmation e-mail shortly after submission, your letter was not received, and you should submit the documentation again.
12. **Project members are responsible for the humane care of their animals from the time the animals arrive at the fairgrounds until the animals leave the fairgrounds.**
13. Animals sold at the sale will be released at 8:00 am on Monday, September 2nd. **If the processing trailer arrives earlier than 8:00 am, animals going to processing plants may be released earlier than 8:00 am.** If the animals are not going to a processing plant, **they must be removed from the fairgrounds no later than 11:00 am on Monday.**
14. **Barn decorations cannot be removed before 8:00 am on Monday, September 2nd. If you have questions regarding barn regulations, talk to your barn supervisor or refer to the Portage County Fair Book, page 3 and 4, rules 22 and 28.**

H. CARCASS CONTEST

1. All animals sold at the sale that have unacceptable meat as judged by the state or federal inspector after slaughtering will be subject to an adjustment between the buyer and seller under the direction of the Committee.
2. Animals found to have retained testicles (cryptorchid) at time of slaughter will be disqualified from the carcass contest.
3. Swine hot carcass must be 170# or more with at least 0.5" back fat or it will be moved to a lower placing.
4. Market Animal Project Members may only enter the animal sold in the sale in the Carcass Contest, unless their sale animal is not processed where the carcass contest is held. Processing of the animal is at the discretion of the buyer.

Interpretations of questions of all the preceding rules, or questions caused by them, will be evaluated by the Market Animal Committee.

I. THE MARKET ANIMAL COMMITTEE ENCOURAGES MEMBERS TO:

1. Exhibit at the Amherst Fair for experience in fitting and showing.
2. Be in attendance for the entire sale to help and support other exhibitors.
3. Be prompt in sending their thank-you notes to the buyers and bidders of their animals. **Thank-you notes are a requirement.** See the participant eligibility requirements on page 2.
4. Take personal responsibility for the handling, feeding, caring, and fitting of their animal(s) throughout the project, beginning with weigh-on and ending on the final day of the fair after barn cleanup. Expectations and consequences are outlined in the Animal Care Agreement. Refer to the Portage County Fair Book, page 6.
5. **Weigh project animals regularly to make sure weight goals are being achieved.**

J. MARKET ANIMAL PROJECT CODE OF CONDUCT

All animal exhibitors need to refer to the International Association of Fairs & Expositions (IAFE) National Code of Show Ring ethics. These guidelines will be enforced. See the Portage County Fair Animal Exhibitor's Code of Ethics in the Portage County Fair Book, pages 5 and 6.

Exhibitors of animals at livestock shows and in the sale ring, along with their parents and guardians, will be expected to:

- **Show respect for the rights of others, be courteous at all times and use appropriate language.**
- **Demonstrate sportsmanship in the show ring, contests, and meetings.**
- Be honest and do not take unfair advantage of others.
- Respect the property of others.
- Be available to provide information about your exhibit or give directions if needed.
- All judges, fair and livestock show management, show officials and **bidders and buyers**, shall be treated with courtesy, cooperation and respect. No person shall direct abusive or threatening conduct toward them.
- All exhibitors shall be treated with respect and good sportsmanship.
- All show animals must remain in barn areas (barns, wash racks, and immediately adjacent walkways) once animals have been checked in by barn superintendent.
